The new law restricts each phthalate to no more than 0.1% in each homogeneous material of an electrical product.

(3) The restriction of DEHP, BBP, DBP and DIBP shall apply to medical devices, including in vitro medical devices, and monitoring and control instruments, including industrial monitoring and control instruments, from 22 July 2021.






